Discussion was held regarding Freedom Township fire contract. \$66,500.00 might be the new cost, based on Jim Cajka's calculations. Further meetings with Freedom Township trustees are warranted. Discussion was held regarding roadside clean-up day. Isaac Bailey will select a day toward the end of May. Corey Speweik to help coordinate with Adult probation, Perrysburg probation, Bowling Green Probation, and Wood County juvenile probation.




