The meeting opened with the Lord's Prayer.

The minutes of the July 13, 2015 meeting were read and approved as written.

The treasurer's report for July was read and approved.

Discussion was held regarding solid waste recycling. A representative from Eastwood Band Boosters was present to answer any questions regarding the Township's recycling program.

Mark Mohre tendered his resignation effective 9/7/2015 due to work obligations.

Bids were opened for the Caris Road project. Bids were received from Bergman and Whitta as follows:

- Bergman: \$66,875.00 (hot mix), \$64,362.00 (cold mix)
- Whitta: \$75,136.50 (cold mix)

Discussion was held regarding the best bid. It was decided to award the project to Bergman using cold mix for \$64,362.00. Isaac made motion, second by Jim. Motion carried. An inspector from the Wood County Engineer's Office will oversee the project.

Discussion was held regarding Dowling Road and the traffic issues thereon. Jim Cajka discussed the problems with Wood County Sheriff and Wood County Engineer. It was noted that due to the construction projects on 582 and I75, there is very little that can be done.

Discussion was held regarding the cement-filled basin on Silverwood. Isaac Bailey to talk with Dana Ameling regarding the issue. It was noted that the contractor who poured his sidewalk may have cleaned out the truck in the basin.

Discussion was held regarding zoning issues. Dave Welling has conducted an audit of the township and will submit a report to the Trustees.

Discussion was held regarding the tree on Burgess Rd. Phil Farmer committed to paying for half of the removal. Trustees will seek bids for the removal.

Discussion was held regarding Mark Mohre's replacement. Isaac Bailey expressed a desire to post the position and accept resumes and begin the interview process. Deadline for resumes next meeting. Ad to run for three days. Applicants must have a valid CDL or be able to obtain one and submit to drug test and background check.
