The meeting opened with the Lord’s Prayer. The minutes from the December 13, 2021 meeting were read and approved.

Isaac Bailey reported the nuts and bolts for the LTAP sign grant have arrived, and the signs should be arriving soon.

Jim Cajka reported the electricity installation at the Webster School property was not on Toledo Edison’s schedule for some reason but is again now.

Randy Aspacher is going to take the tractor up to Redline to get the air conditioning fixed and a block heater and strobe lights installed.

There was nothing to report on abandoned houses.

Randy Aspacher is still planning on making two kiosks this coming year. Wreaths Across America was held on December 18. There were less people at Webster Township Cemetery than in previous years, most likely because the people were more spread out over the additional cemeteries that hosted the event this year. Mark Bushman mentioned there are multiple veterans buried at Old Belleville Ridge Cemetery that do not have markers and wondered if the township could purchase markers through the Veterans Affairs office.

One barricade was purchased and the expense will be used towards the MORE grant through OTARMA. Julie Foos will apply by December 31.

Jim Cajka will see what needs to be done with the township hall floor before it is refinished.

There was nothing to report on renewing the terms for the zoning boards members.

Julie Foos reported the township will receive around 85% of the allocated estate tax revenue in March.

Julie Foos mentioned the Trustees, Randy Aspacher, and Mark Mohre’s driving records show they may continue to drive the township’s vehicles per the Driving Policies and Procedures.

The Trustees signed the Purchase Orders and Blanket Certificates for the first quarter of 2022.

Randy Aspacher reported Troy Township has an auger box they want to get rid of that could be used for the berming machine. Randy Aspacher would like to have a bunch of concrete blocks hauled in to the Webster School property.

Isaac Bailey told Jason Sisco that Webster and Freedom Townships are interested in applying for the OPWC grant for improving Swam Road.


